Roll Call Vote to approve amended motion: Brown-No, Mertz-Yes, Fockler-No, Stryeski-No, Adams, Yes. Motion failed.

The Board returned to the original motion where it was moved by Fockler, seconded by Adams to adopt Hazard Pay until next Board meeting, or until Collins calls back laid off drivers, in the amount of an additional \$5/hour for drivers and \$3/hour for all remaining on-site staff. Roll Call Vote: Brown-Yes, Mertz-Yes, Fockler-Yes, Stryeski-Yes, Adams-Yes. Motion carried.

- X. Isabella County Transportation Commission Mertz inquired about what services we are providing as far as food deliveries and essential transportation.
